### RELEASE OF LIABILITY AND ASSUMPTION OF RISK

This Release of Liability and Assumption of Risk Agreement ("Agreement") is made between Emerald Empire Gun Club and the individual whose name and signature appears on the bottom of this agreement ("undersigned"). The Emerald Empire Gun Club ("EEGC") is a shooting range and training facility located at 36111 McGowan Creek Road in Springfield, Oregon that hosts active shooting ranges for firearms and archery equipment ("firearms"), in addition to providing meeting spaces for Club meetings, firearm safety classes, related trainings, and other events. By the nature of its business, all entrants onto EEGC property and facilities will have direct contact with active firearms, which necessarily includes the undertaking of all risks inherent to that contact.

## **Release Agreement**

The undersigned understands and agrees that this Agreement is made in consideration for the use of the equipment and facilities of the EEGC, including access to the EEGC's property and improvements, whether as a member or guest of the EEGC, or as a guest for an unrelated event hosted on the EEGC's premises. The undersigned further understands and agrees that use of the EEGC's facilities will place the undersigned, and/or his or her guests, including minor children, in direct contact with the use of firearms including all risks inherent to that contact, which can include, but are not limited to, the following, all of which can bring a significant risk of damage to personal property, severe bodily injury, and death:

- · Accidental discharge of firearms
- · Intentional or unintentional improper use of firearms
- · Ricochets and flying fragments
- · Defective firearms and/or ammunition
- · Excessive noise
- · Bright lights or flashes
- · Excessive heat
- · Lead and Other Heavy Metals Exposure
- · Improper Storage or Care of Firearms

By signing this Agreement, the undersigned knowingly and voluntarily releases the EEGC from any and all claims for damages for persons or property, including for serious bodily injury or death, which the undersigned, or his/her minor children, may suffer in connection with the undersigned's, or his/her minor child's of the EEGC property and facilities, or from the action or inaction of any officer, manager, employee, agent, member, guest, or other visitor of the EEGC. THIS UNDERSIGNED EXPRESSLY WAIVES ANY CLAIMS FOR LIABILITY THE UNDERSIGNED, OR HIS/HER MINOR CHILDREN, MAY HAVE AGAINST THE EEGC FOR ITS OWN NEGLIGENCE OR THE NEGLIGENCE OF ITS OFFICERS, MANAGERS, AND EMPLOYEES.
